Dr. Sigrid Berka is the Executive Director of the International Engineering Program (IEP) at the University of Rhode Island, and also the Director of the German and the Chinese IEP. She is a native of Germany and has a Staats-examen in German Literature, Philosophy, and Education from RWTH Aachen (1986), and a PhD in German Studies from the University of California, Santa Barbara (1990). Her book *Mythos-Theorie und Allegorik bei Botho Strauss* came out in 1991. She also co-authored an intermediate text book for German language, *Spiralen*, and has written many articles on German and Austrian writers of the nineteenth and twentieth centuries.

Norbert Hedderich, University of Rhode Island, is Professor of German and Chair of Modern Languages at the University of Rhode Island where he also directs the German Summer School of the Atlantic. His area of specialization is German-language pedagogy, German applied linguistics, and the teaching of languages for special purposes.

Orlando R. Kelm, University of Texas at Austin (PhD, University of California, Berkeley) is an Associate Professor of Hispanic Linguistics at the University of Texas at Austin where he teaches courses in Portuguese and Spanish, focusing mainly on business language and the cultural aspects of international business communication. He also serves as the Associate Director of Business Language Education at the UT CIBER (Center for International Business Education and Research). Professor Kelm's research and publications center on the cultural aspects of international business and the pedagogical applications of innovative technologies in language learning. His most recent online materials development project is entitled "Conversa Brasileira" and his most recent book (coauthors: John N. Doggett and Haiping Tang) is entitled *When We Are the Foreigners: What Chinese Think about Working with Americans*.

Nancy Smoller Le Floch, Fulbright scholar and Chevalier in the *Ordre des Palmes Académiques*, has developed and taught courses on cultural differences based on her years spent in the United States, Europe, and Japan. She has also managed a company affiliated with a South Korean pharmaceutical firm.

Amel Mili, University of Pennsylvania, holds a JD in Private Law from the Law School of Tunis and a Master's in Public Administration from The University of Tunis. She also holds a Master's and a PhD in Global Affairs/

Political Science from Rutgers University, Newark. She currently serves as director of the Lauder Arabic Language and Culture Program at the University of Pennsylvania.
