In order to make an exception to our policy, we would greatly appreciate reviewing the graphic and excerpts you wish to leverage in the context in which it will appear. If your draft content is not available at this

time, we would need to understand how this graphic will be used to ensure accuracy and appropriateness. While the URL provided is in the public domain, it is licensed to Oracle and the licensing window will expire in October 2010, so this is not the appropriate citation.
