The reputation of the journal worldwide and its publication in open access brings Purdue a high level of brand recognition and while this is difficult to gauge with regard to finances, *CLCWeb* brings significant recognition of scholarship to Purdue.

1) 2006 is an odd year in the publication of the journal: we published 31 articles while we received 62 submissions. What is odd is the rate of rejection to publish because of the quality of the submissions based on the readers' evaluation.

2) In 2006 there were no thematic issues published in the journal; however, in preparation for publication in 2007 is the thematic issue *Representing Humanity in an Age of Terror* guest edited by Sophia A. McClennen and Henry James Morello (both at The Pennsylvania State University).

3) Much work has been devoted to the publication of books in the CLCWeb affiliated Purdue series of Books in Comparative Cultural Studies; however, owing to the illness of the managing editor of Purdue University Press—Dr. Margaret Hunt and who passed away to our consternation, the Press, and many past and present authors of books published by Purdue—no volume was published.

4) Margaret Hunt assisted with the design of the journal's format for the up-coming conversion of the journal to the digital commons publication by the Berkeley Electronic Press on behalf of Purdue University Press. I would like to express my gratitude and appreciation for Margaret's work with regard to the journal and the book series.

5) The journal's book review editor—Henry James Morello (The Pennsylvania State University)—continues to

1) I begin with an apology for the delay in issuing the yearly report on the activities and status of affairs of our journal for 2005: the reason for the delay was that I was holding off until my discussion with Purdue came to a conclusion about the journal's move to a Purdue University-wide platform of electronic publishing and maintenance of electronic data (please see below 3, 10).

2) In 2005 we received 51 submissions, of which 37 papers (articles, book review articles, and bibliographies) were published (thus, we received more papers for publication than in 2004 while we published an identical number of papers). The year's work in the journal includes two thematic issues—7.2 on new work in American cultural studies" ("American," because the issue includes scholarship about US-American and Canadian culture), guest edited by Joanne Morreale and P. David Marshall (both at Northeastern University) and 7.4 on media and communication studies at the University of Halle-Wittenberg," guest edited by Reinhold Viehoff (University of Halle-Wittenberg). Halle-Wittenberg).

3) We had a meeting of Advisory Board members at the annual ACLA: American Comparative Literature association conference held at The Pennsylvania State University in March 2005 (where the journal was represented with panels of papers on comparative cultural studies). A number of issues re the journal were raised and discussed. Overall, my sense was that Board members present at the meeting approved the work of the journal. Dissenting opinions include aspects of the visual presentation of the journal and I hope these criticisms would be alleviated with the move of the journal to the Purdue-wide platform in digital commons and sub-published in pdf by the

Berkeley Electronic Press (see below 11).

4) In 2005 the journal was assisted by editorial assistants Patricia I. Vieira (Harvard University) and Luz Angelica Kirschner (Pennsylvania State University). As of 2006, Vieira and Kirschner are resigning and we thank for their dedicated service to the community of scholars and the journal (their names and years of service are included in the page of the history of the journal, as are the names of all Board members and editorial assistants since the start of the journal). As of 2006, Agata Anna Lisiak (University of Halle-Wittenberg, doctoral student of the editor) is the journal's editorial assistant. A call for new editorial assistants will be issued in September (Board members

is the journal's editorial assistant. A call for new editorial assistants will be issued in September (Board members are encouraged to promote the position in their departments or where appropriate).

5) At the above mentioned Board meeting at Pennstate, Henry James Morello (Pennsylvania State University) graciously accepted to serve as our new book review editor: his tasks include the updating of the international directory of comparatists in the journal's *Library*.

6) A thematic issue is forthcoming on representing humanity in an age of terror guest edited by Sophia A. McClennen and Henry James Morello (both at The Pennsylvania State University). Several thematic issues (on race in children's literature, on Canadian and Australian literature, on Lusophone literatures, etc.) are now at various stages of planning for publication in subsequent issues.

7) The statistics of web traffic and use of the journal continue to rise, by the end of 2005 to 9000 hits per day, with the correspondingly increasing amounts of page views, unique visitors, length of use, etc., see at <a href="http://clcwebjournal.lib.purdue.edu/stats/index.html">http://clcwebjournal.lib.purdue.edu/stats/index.html</a>.

8) In 2005 15 listserv mailings of *CLCWeb News* were sent out: board members are encouraged to send items of interest to <clcweb@purdue.edu</a>.

9) In the *CLCWeb* affiliated Purdue series of Books in Comparative Cultural Studies we published three volumes in 2005: Camilla Fojas (DePaul University), *Cosmopolitanism in the Americas*; *Imre Kertész and Holocaust Litera-*

- in 2005: Camilla Fojas (DePaul University), Cosmopolitanism in the Americas; Imre Kertész and Holocaust Literature edited by Louise O. Vasvári (State University of New York Stony Brook) and Steven Tötösy de Zepetnek (University of Halle-Wittenberg); Comparative Cultural Studies and Michael Ondaatje's Writing edited by Steven Tötösy de Zepetnek (CLCWeb annual 3). We continue to receive, on the average, between six to eight manuscripts per calendar year. At this point there are 16 books in the process of evaluation, in editing, and/or in waiting to be published. The problem of delays and the restriction of now two books per year—instead of the agreed two to three books per calendar year—by the Press remains an issue and we are in continuous discussion with the Press on this matter.
- 10) In 2005 Purdue University Press and Purdue University Libraries (the publishers of the journal: Purdue University Press as the legal publisher and Purdue University Libraries as the publisher of the electronic location of the journal on the server of the Purdue University Libraries) advanced to implement a university-wide platform of journal publishing and the maintenance of electronic data at Purdue in digital commons and published by the Berkeley Electronic Press (BEP). It is planned that the journal would be moved into the said platform, including a re-design of the journal's visual appearance. I am working with a designated technician at BEP on the transfer of the journal onto the new platform. It needs to be noted that this requires an inordinate amount of work as each and every paper published in the journal since 1999 will have to be reformatted to the new format: this will take time. I expect the complete overhaul of the journal and its presentation in the new format to conclude in early to

mid-2007. We thank Purdue University Press and Purdue University Libraries for their support of the journal and their continuous efforts to improve the presentation of our journal.

**2004 Annual Report** *CLCWeb: Comparative Literature and Culture* 7 January 2005
1) In 2004 the journal received 45 submissions, of which 37 papers (articles, book review articles, and bibliographies) were published. The year's work in the journal includes two thematic issues—Shakespeare on film in Asia and Hollywood guest edited by Charles S. Ross (Purdue University) and comparative cultural studies and Michael Ondaatje's writing guest edited by Steven Tötösy de Zepetnek—and two regular issues. The Shakespeare issue is planned to be published in the Purdue University Press Series of Books in Comparative Cultural Studies and the Ondaatje issue is scheduled to be published as a volume in the series in January 2005, both as CLCWeb annuals.

2) International Advisory Board: in 2004 we welcome Paolo Bartoloni (director, International and Comparative Literary Studies, University of Sydney) and Colin B. Grant (professor, Intercultural Studies, Heriot-Watt University) as new members. Elizabeth Flynn (Michigan Technical University) resigned from the board owing to her retirement:

we thank Elizabeth for the six years she served on the Board.

3) Journal editorial assistants Claire Callaghan (U of Maryland & Catholic U of America) and Joyce Yee (North-umbria University) completed their term: we thank them for their outstanding work with the journal.

4) The matter of book review articles has not been resolved since last year: we do not have a book review editor; also, publishers have still not discovered the benefits of book reviews online and it remains circumstantial and difficult to receive books for review, not to speak of the problem of finding book review article authors. Thus, in the next while, book review articles will appear occasionally, that is, not with each issue but intermittently whenever possible.

5) The cumulative index of publications in the journal have been restructured in that in each volume's fourth issue there is now a page of "the year's work" of publications in alphabetical order of authors and the same structure is in place in the page of the cumulative index of the journal.

6) The statistics of the use of the journal continues to surprise: daily hits are between 4700 (January 2004) and 7500 (November 2004), with the correspondingly high number of page views, etc., from all corners of the world, and I receive, continuously, email with appreciation and praise of the journal. Although to date this has not translated itself to more tangible recognition and/or a prize from an established literary or cultural organization/association, the journal remains one of the few peer-reviewed, full-text, and open-access journals in the humanities, anywhere. Also, most if not all university libraries across the U.S., Canada, and West Europe list and link to the journal in their electronic resources data banks.

8) On the journal's listserv, we sent out 10 *CLCWeb News* in total.

9) In the *CLCWeb* affiliated Purdue series of Books in Comparative Cultural Studies the following books appeared: Sophia A. McClennen, *The Dialectics of Exile: Nation, Time, Language, and Space in Hispanic Literatures*; Sophia A. McClennen and Earl E. Fitz, eds. Comparative Cultural Studies and Latin America (*CLCWeb* annual 2), and Jin Feng, *The New Woman in Early Twentieth-century Chinese Fiction*. The series continues to receive a good number of mss, which in fact creates a problem since Purdue allows maximum three to four volumes per calendar year in the series and we receive at least double that. Thus, several outstanding mss had to be rejected.

1) In 2003 four issues of the journal have been published, with a total of 23 articles, 2 book review articles, and 2 bibliographies, 1 issues of the four regular issues is thematic (guest edited by Benton Jay Komins 5.3 (2003): Comparative Cultural Studies and Popular Culture. The journal received 41 submissions in total and rejected 18 in total.

2) The journal is indexed in the MLA: Modern Language Association International Bibliography, as of 2003 in the Humanities Index and in the American Humanities index while the indexing of its material in the Arts and Humanities Index of ISI: Web of Science <a href="http://www.isinet.com">http://www.isinet.com</a> is pending approval: unfortunately, ISI bases listing and abstracting upon the amount of citation in print-copy journals (!) and we are all aware about the slow pace of the humanities to recognize online learned journals even when such are peer reviewed which results in few citations of material in *CLCWeb* in print journals.

3) Upon a new call for interest, in 2003 CLCWeb is served by 5 editorial assistants: 3 in the U.S., 1 in Spain, 1 in the United Kingdom, whereby 1 editorial assistant (Purdue) is with graduate student funding for the work while

the others are volunteers.

4) The visual looks of *CLCWeb* has been redesigned at the University of Halle-Wittenberg (Germany, where I was appointed professor of media and communication studies) by internet technicians Michael Ginolas in dreamweaver and with the assistance of internet technician Rasmus Schwinghammer.

5) The journal is archived continuously by the National library of Canada and maintains mirror sites on the site of the British Comparative Literature association (United Kingdom) and at the International Consortium for the Advancement of Academic Publication (Canada).

6) Technical support to the journal continues by Purdue re the journal's site search engine, monthly web traffic

6) Technical support to the journal continues by Purdue re the journal's site search engine, monthly web traffic reports, listserv, and the server space for the material of the journal; continuing since 2002 the Department of Media and Communication Studies, University of Halle-Wittenberg (Germany), provides technical service for design and new features of the journal.

7) The journal's web traffic statistics suggest continuous and high amounts of use, e.g., averages of 5000-6000 hits per day and with the corresponding high amounts of unique visitors, page views, etc.

Ross and on media studies at the University of Halle-Wittenberg guest edited by Reinhold Viehoff. 10) An example of the journal's growing reputation is that the journal is the featured journal of March 2004 of the CELJ: Council of Editors of Learned Journals <a href="http://www.celj.org/">http://www.celj.org/</a>> and that the editor of the journal has been nominated for the U.S. Lyman Award.

11) A number of the International Advisory Board members have not been in touch with the journal and these members are invited to let the editor know whether they plan to be affiliated further with the journal, members are invited to send the editor items about new publications and professional news for placement on the CLCWeb listserv.

12) While colleagues subscribed to the CLCWeb listserv (~800 worldwide) sent a number of emails to the editor requesting the level of previous listserv news, the CLCWeb listserv has become less active with items sent out in 2003 owing to the drastic proliferation of online sites with humanities and social sciences news re conferences and related professional news.

13) Unsatisfactory is the matter of book review articles published in the journal: this is owing to the lack of a book review editor since 2002 and to the lack of willingness of publishers to comply with the requirements of copies to the journal and to the perception that book reviews in an online journal would not be as valuable as in a print-

copy journal.

14) New in the journal's *Library* are a number of new and updated bibliographies in a number of fields (textual studieś, systemic and empirical approaches, audience studies, Shakespeare on film in Asia and Hollywood, etc.), all with the assistance of editorial assistants, as well as the updated lists of comparative literature journals and the new list of (comparative) media and communication studies journals.

10) The editor has met in person with *CLCWeb* International Advisory Board members Remo Ceserani (at Brown University, USA), Bart Keunen (at Ghent University, Belgium), and with editorial assistant Patricia Vieira (in

Winchester, Massachusetts).

11) The new index page of the journal: after many attempts and trials and with the generous assistance of Carl Snow (Purdue University Libraries) and Florian Hartling (University of Halle-Wittenberg), the new index page has matured, including a site search engine, a cumulative index of material in the journal, etc. The one suggestion by several members the journal's Board that thematic issues' titles be inserted in the dynamic menus of issues could not be done, unfortunately. We tried several ways but in each case the titles, when inserted into the pop-down menus, appeared too crowded and after several trials we abandoned it. I would like to thank Snow Hartling for their web design work on the new index page, all free of charge and owing to their commitment to scholarship online in the humanities. Needless to say, the fact that Purdue University Press publishes our journal in full text and in open access is exceptional, far-sighted, and socially responsible indeed: to date, as we know well, there are few journals online in the humanities that are offered to the community of scholars in open access. The continued large amount of use of the journal across the globe is proof that Purdue University Press, authors who publish in the journal, and members of the journal's International Advisory Board perform an invaluable and much needed results in much increased brand/name recognition of Purdue University Press which, in turn, will translate itself into monetary gains in several ways. Please take a look at the web statistics of February 2002 (link to the stats from the index page) and you will see that the average number of hits amounts to nearly 2000 hits a day now with the corresponding high amount of page views.

12) In 2002 in the *CLCWeb* affiliated Purdue University Press monograph series of Books in Comparative Cul-

tural Studies the first volume appeared in the series: Comparative Central European Studies edited Steven Tötösy

de Zepetnek.

## 2001 Annual Report CLCWeb: Comparative Literature and Culture 3 January 2002

1) Volume 3 (2001) of CLCWeb is online with four issues published (two regular issues and two thematic is-

sues). The volume of the year has is 34 articles, 4 review articles of books, and 1 bibliography.

2) In 2001, the journal received an increased number of submissions, in total 36 papers (the two thematic issues of the volume not counted as the quest editors were invited editors, from the 36 papers received 14 papers were accepted and published).

3) In May 2001 Purdue University Press director Thomas Bacher and CLCWeb editor Steven Tötösy met at Purdue úpon thé invitation of the Press (see interim report below). One of several results of the meeting is the extension of the journal to books in comparative cultural studies the Press now publishes. With three to four volumes per

year, the first volume of the new series is due out in early 2002; several more volumes are accepted for publication (see below) and several volumes are in the process of consideration and evaluation.

4) The new Purdue series of books in comparative cultural studies (CCS-Purdue) include yearly volumes with selected papers from the journal, arranged as thematical volumes. The first annual of the journal is a volume for 2001, Comparative Literature and Comparative Cultural Studies and containing selected articles from papers published. lished in the journal 1999-2000. The material has been submitted to the Press in November 2001 and the volume Ilsned in the journal 1999-2000. The material has been submitted to the Press in November 2001 and the volume is expected to be in hand by Spring 2002. Thus, the new series is to date with the following volumes: 1) Comparative Central European Culture. Ed. Steven Tötösy de Zepetnek. West Lafayette: Purdue UP, 2002. 220 pages, bibliography, index. ISBN 1-55753-240-0. US\$ 24.95; 2) Comparative Literature and Comparative Cultural Studies. Ed. Steven Tötösy de Zepetnek (CLCWeb annual, 2002); 3) Sophia McClennen, The Dialectics of Exile: Nation, Time, Language, and Space in Hispanic Literatures (2002); 4) Comparative Cultural Studies of Latin America. Ed. Sophia McClennen and Earl E. Fitz. (CLCWeb annual, 2003), and a call for papers has been issued for a volume in the series, Comparative Cultural Studies and Popular Culture, edited by CLCWeb International Advisory Board member Benton Jay Komins.

5) Purdue University Press organized an exhibitor's booth at the 2001 annual Convention of the MLA: Modern Language Association of America (New Orleans) and where the new series if Books in Comparative Cultural Studies has been launched and the journal introduced. Several members of the CLCWeb International Advisory Board has been launched and the journal introduced. Several members of the *CLCWeb* International Advisory Board helped out in the booth and a meeting of several board members present at the Convention was held on 29 December 2001. Also at the Convention, the editor engaged in a discussion with one of the members of the executive of CELJ: Council of Editors of Learned Journals <a href="http://www.celj.org/">http://www.celj.org/</a> (with Purdue, *CLCWeb* is a paid-up member of the Association) with regard to the feasibility to institute a new award category for online journals. Thanks to the Press and Thomas Bacher for the funding of the booth, the editor's travel and hotel expenses, and the costs of a dinner for the journal's advisory board. In December 2001 the editor of the journal met advisory board member Remo Ceserani at Brown University where he was on a visiting professorship. Among other matters, cooperation between the Furopean Union funded comparatist web site. Synapsis between the European Union funded comparatist web site, *Synapsis* <a href="http://www.unisi.it/synapsis/synaps times during the year.

6) Editorial assistance: Steven Aoun (Monash U) continues to serve as editorial assistant of the journal; editorial assistant Wendy C. Nielsen (U of California Santá Barbara) has been appointed book review editor (Nielsen continues, as well, with the updates of the international directory of comparatists). Upon a new call for collaboration as editorial assistants and/or librarians with *CLCWeb*, the journal received 8 notes of interest and two young scholars were selected: for 2002, Cand. Ph.D. Marta Guirao (University College London) and Cand. Ph.D. Patricia I. Vieira (U of California Santa Barbara) are appointed as editorial assistants. The Purdué University Program of Comparative Literature succeeded in obtaining a graduate assistantship for a student in their Program to work for *CLCWeb* and the student will begin as an editorial assistant for one full term in August 2002. Thanks to the chair of the Purdue

Program, Charles S. Ross, for organizing the graduate assistantship.

7) The high web traffic of the journal continues: the journal's material is accessed up to 1500 hits per day on the average and visits and page views are equally high thus indicating the high-level use of its various materials (a detailed evaluation of the traffic on and use of the journal is planned). And interesting news arrive, for example: Leonard Orr, editor of the *International Review of Modernism: A Journal of Scholarship on the Literature and Culture of Europe, 1890-1939* <a href="http://www.modernism.wsu.edu">http://www.modernism.wsu.edu</a> writes: "The excellent job you have done with CLCWeb has been a model for me in changing the form of the International Review of Modernism from traditional print form to an e-journal" (e-mail of on 25 December 2001).

8) Work continues to contact and to encourage university libraries and databases in the humanities and the social sciences to list *CLCWeb* in their electronic resources. With regard to the matter of scholarship, visibility, and the question of free access, the editor discussed with the director of the Press the feasibility of converting *CLCWeb* into a paid subscription-based journal; however, by mutual agreement for now the journal remains in the mode of

into a paid subscription-based journal; however, by mutual agreement for now the journal remains in the mode of free access (and against the trend in scholarly publishing).

9) The adjustment of the journal's index page by Purdue is still awaited. These adjustments include the input of a site search engine capable of searching with diactritics, pop-down menus of volumes with issues with titles if/when needed, a general index, and a standard graphics page for all materials published in the journal. With 3.2 (2001), the MLA format of numbered paragraphs has been adopted. A style sheet of the journal will be added to the page of the journal's process of publication.

2001 interim report *CLCWeb: Comparative Literature and Culture* 27 May 2001

1) This interim report is about meetings the editor of the journal had—invited by the director of the Press Thomas Bacher at the cost of Purdue—in West Lafayette on the campus of Purdue University 14-18 May 2001.

2) Support of the journal is strong by the Press, the Program in Comparative Literature, and the dean of libraries; interest in the journal, as well as co-operation have also been expressed by the chairs of the Department of Modern Languages and Literatures and the Department of English.

3) Adjustments and additions to the index page and other pages of the journal: all adjustments should be com-

- pleted in the summer months, incl. such features as pop-down menus with space to input titles of thematic issues, a site search engine, template pages for the articles, etc. These tasks are executed by the editor of the journal.

  4) The Press will advertise of the journal with the MLA: Modern Language Association of America, as well as in the PMLA: Publications of the Modern Language Association of America (the Association's official journal), and in The Chronicle of Higher Education.
- 5) The Press will contact pertinent indexing agencies including the Arts and Humanities Citation Index in order to strengthen the presence of the journal (the journal is already indexed in the MLA: Modern Language Association of America International Bibliography).

6) The Press and the editor of the journal agreed that CLCWeb: Comparative Literature and Culture is to remain in full text and in open access.

7) Plans are in place to organize one revolving internship (editorial assistant) for the journal, funded by Purdue's Program in Comparative Literature and the Press.

8) The Press agreed to pay the annual institutional membership of the journal with CELJ: The Council of Editors of Learned Journals <a href="http://www.celj.org/">http://www.celj.org/</a>>.

9) The Press extended an invitation to the editor of the journal for the publication of a new print monograph series—with Steven Tötösy de Zepetnek as series editor—including print thematic annuals of *CLCWeb: Comparative Literature and Culture*. The series is thus affiliated with *CLCWeb: Comparative Literature and Culture* and is named the "Purdue University Press of Books in Comparative Cultural Studies." The series is intended to publish both single-authored and collected volumes. The latter must be thematic volumes (i.e., no conference proceedings). The offer by the Press is significant for humanities scholarship also because the Press offers royalties to authors and does not require authors to provide subsidy funding for the publication of books it publishes (unlike most university presses in Canada and by now many university presses in the U.S.).

10) Purdue offered to the editor an e-book device so that the journal can be advertised as per occasion by e-

1) The relocation of the journal from the University of Alberta to Purdue University Press went smoothly: the new address of the journal is <a href="http://clcwebjournal.purdue.edu">http://clcwebjournal.purdue.edu</a>. There are still a few outstanding items such as the input of a site search engine on the index page, adjustment of spacing of items and new items on the page, etc. Purdue graciously agreed to purchase for the journal membership with CELJ: Council of Editors of Learned Journals <a href="http://www.ceij.org/">http://www.ceij.org/</a>. Purdue also agreed to purchase the software program endnote for work with the bibliog-

rattp://www.ceij.org/>. Purdue also agreed to purchase the software program endnote for work with the bibliographies in the CLCWeb Library Series of the journal. Purdue will announce the relocation of the journal in the PMLA:

2) In 2000 the journal published 32 papers and 4 book review articles. 4 papers were rejected in total. Highlights include a thematic issue on histories and concepts of comparative literature and the publication of an article in English translation by Nobel Laureate José Saramago and an article by the acclaimed translator, Mabel Lee, who is a member of the journal's International Advisory Board, on the work of this year's Nobel Laureate Gao Xingjian—

both articles in 2.3—are also highlights.

3) The work of editorial assistants Steven Aoun (University of Melbourne) and Wendy Nielsen (University of California San Diego) has been exemplary and to the benefit of the journal and its users. Nielsen contacted a large number of comparative literature departments and programs over the globe and with the incoming data updated the international directory of comparatists (new updates are on-going) and she has been dealing with publishers to organize books for the journal's book review articles. Aoun assisted in the editing of papers in the 2.4 thematic is a betaling and concepts of comparative literature and is working on new data for hibliographies in the journal is working on new sue on histories and concepts of comparative literature and is working on new data for bibliographies in the jour-nal's library. Both agreed to stay on for 2001 and serve the journal. It should be noted that there is the possibility that further assistant help may be added to the journal if and when Purdue decides to fund such a position.

4) In 2000 the journal welcomes Thomas Bacher (Purdue University Press), Sneja Gunew (University of British Columbia), Bart Keunen (Ghent University), Sophia A. McClennen (Illinois State University), Anthony Tamburri (Florida Atlantic University), and William Thornton (National Cheng Kung University) to its International Advisory

Board

5) The MLA: Modern Language Association of America International Bibliography indexes and lists material pub-

lished in the journal.

6) An agreement has been reached with BCLA: British Comparative Literature Association for the BCLA to mirror the journal on the site of the association. The decision to mirror the journal on the BCLA site is the result of a decision by the executive of the Association at its recent meeting upon a letter of interest issued by the journal's editor in early 2000. The mirror site at the BCLA is advantageous for several reasons: Europeans will have faster access to the journal; should the Purdue server be down, the mirror site functions as back-up; and the journal's mirror at the BCLA reflects the Association's reputation upon the journal. It is planned to organize mirror sites also

in Asia and in Africa for the faster access, etc., of the journal.

7) The use/readership of the journal is expanding steadily: at least this is what the monthly hits and user sessions of the journal and its material indicate. For instance, in November 2000 the journal received a daily average of 985 hits, in the same month the daily average of visitor sessions was 144, and the average daily page view was 316, etc.

8) Links to the journal in pertinent online sites, such as learned associations and journals, long distance education sites, library home pages of universities, comparative library types.

tion sites, library home pages of universities, comparative literature, English, other national language, and culture studies departments, etc., have been increasing during the year and there is a large number of such sites which agreed to link to the journal.

9) The rate of submissions of papers to the journal is low and cause of concern. The low number of submissions is likely owing to several factors such as the opinion of scholars in the humanities ranging from caution towards and/or dislike of online publishing and new media scholarship, the institutional, as well as intellectual limitations of the discipline of comparative literature itself including the limited number of departments of such worldwide when compared with e.g. English, and the fact that the journal is new. Hopefully this situation will improve in the near future

10) It may be advantageous and feasible to explore the possibility of publishing the thematic issue of 2.4, Histories and Concepts of Comparative Literature, in a print book. Suggestions and contacts members of the International Advisory Board may have, preferably a publisher with a series in comparative literature, are welcome.

11) A meeting was held at the Washington Convention of the Modern Language Association of America in December 2000 with members of the Board who happened to be at the MLA. Such articles would be published in two formats, in text only and in new media. The expansion toward such presentation of material is of course the way to go and only the lack of funding stands in the way. If/when the journal succeeds to obtain funding, the thought then can be more seriously entertained.

12) In early 2000 a letter of offer was sent to ACLA: American Comparative Literature Association with the offer that the journal be lighted in amounts to ACLA and the offer included the use of the journal to make the literature.

that the journal be linked in some way to ACLA and the offer included the use of the journal's moderated listserv for announcements of ACLA. At the January 2001 meeting of ACLA's executive it was decided that ACLA does not wish to associate itself with the journal and that it does not wish to use its listsery for the reason that it wants to limit the receipt of unwanted e-mail by the membership of the association (pity.) On their home pages, both ACLA

and ACLANet link to CLCWeb, however.

13) I would like to encourage members of the journal's International Advisory Board to solicit new material for publicátion in the journal and to promote the journal in general. I would also like to encourage members to propose thematic issues for publication, including proposals to act as quest editors of thematic issues.

14) Plans for 2001 include two thematic issues and two regular issues. 3.2 is on emperical aesthetics and the study of culture, guest edited by Aldo Nemesio (University of Torino) and 3.3 is on the internationality of national literatures, guest edited by Marietta Messmer and Barbara Buchenau (both at the University of Göttingen).

2000 Interim Report CLCWeb: Comparative Literature and Culture 23 October 2000

The transition of the journal from the University of Alberta to Purdue University Press has been relatively smooth. There are still some matters outstanding, such as an internal search engine for the journal Purdue agreed to input and I hope that they will input the engine shortly. The interest in the journal keeps increasing based on the number of submissions we receive and the hits the journal is getting, now over 300 hits on the average per day, with the correspondingly high number of user sessions. I am also happy to report that the work of the two graduate student editorial assistants, Steven Aoun (University of Melbourne) and Wendy C. Nielsen (University of California San Diego) is exemplary, effective, and always on time. The journal includes two articles of special interest: Mabel Lee, a member of our International Advisory Board (University of Sydney) is the translator of a major novel of this year's winner of the Nobel Prize in Literature, Gao Xingjian, and she graciously agreed to send us an article about the work of Gao. Clearly, this is a major contribution to the journal and most likely will add to the interest of readers of the journal. Another article in this September issue and that is equally of significance is an article by José Saramago, the winner of the Nobel Prize in Literature in 1998, whom the editor had the occasion to have met (see Saramago, José. *Cadernos de Lanzarote: Diário - II.* Lisboa: Caminho, 1995. 183.)

### 1999 Annual Report CLCWeb: Comparative Literature and Culture 1 February 2000

1) This annual report is the first since the inaugural publication of *CLCWeb: Comparative Literature and Culture*1.1 (March 1999): <a href="https://www.arts.ualberta.ca/clcwebjournal/">https://www.arts.ualberta.ca/clcwebjournal/</a>>.
2) In the inaugural issue of the journal we published articles 7 articles by invitation. Following the publication of the inaugural issue, we received 40 submissions out of which we published 35 articles in issue 2 of volume 1

the inaugural issue, we received 40 submissions out of mines. The journal is organized following the standard format and organization of learned journals with blind peer review of papers submitted for publication, an editor, an International Advisory Board, a book review editor, and editorial assistant(s) who gain training and knowledge under the guidance of the editor in academic publishing, bibliography work, marketing, etc. An electronic journal, *CLCWeb: Comparative Literature and Culture* is no different from learned journals published in print except in its mode of delivery.

3) Funding for the journal by the Social Sciences and Humanities Research Council of Canada in its Journal Programme is not possible because the Council's regulations allow journal funding only if there is proof of minimum 200 paid subscribers. The Council does not accept the argumentation that as an open access electronic quarterly the journal has already a substantial number of readers (based on the journal's web statistics): in Canada journal

funding is available solely for print journals.

4) ISSN number for *CLCWeb: Comparative Literature and Culture*: while in November 1998 an application for the journal for an ISSN number assigned by the National Library of Canada was rejected owing to the National Library's regulations that electronic journals do not receive ISSN numbers, in January 1999 the Library changed its regulations and assigned ISSN 1481-4374 to the journal. *CLCWeb* is the first electronic learned journal that received an ISSN number in Canada. At the same time, the National Library also decided to archive electronic material published on the worldwide web including *CLCWeb: Comparative Literature and Culture*. As far as I know, at this point Canada is the first country to archive worldwide web publications.

5) The journal is published in html designed by the editor of the journal; unusual features of the journal are a Library where research material such as bibliographies, papers, research material, and a directory of comparatists with specializations, institutional postal, and email addresses is presented, as well as listserv postings with news and items of interest sent monthly to subscribers (similar to the journal itself, subscription to the listserv is at no cost). The University of Alberta Faculty of Arts server provides the URL for the journal and the necessary server space for the web location of the journal. The University's Help Desk and the University of Alberta Faculty of Arts Technologies for Learning Centre at <a href="http://www.humanities.ualberta.ca/TLC">http://www.humanities.ualberta.ca/TLC</a> provides occasional technical help for the journal and its functions.

6) Following the two first issues of the journal, the editor received inquiries from university presses in Canada and the U.S. (University of Toronto Press, Stanford University Press, Northeastern University Press, University of California Press, MIT Press, and Purdue University Press) about whether there would be interest to publish the journal remains in open access and not subscription based. Except Purdue University Press none of the presses pursued their offer further. Following extensive discussion, Purdue University Press accepted in December 1999 the publication of the journal: Purdue's offer includes server space and minimal technical assistance with regard to the journal's listserv but is unable to offer any further assistance with regard to matters technical, webdesign or funding. Following email correspondence with members of the journal's International Advisory Board, it has been agreed to accept Purdue's offer and thus the journal will be relocated to Purdue University Press starting with issue 2.2 (June 2000) and including volume 1.1-4 (1999), issue 2.1 (2000), and the *Library* of the journal. Needless to say, publication by one of the top university presses in the U.S., the journal will gain in prestige.
