Carlos Coria-Sánchez is Associate Professor of Spanish and Co-director of the Business Spanish Certificate at The University of North Carolina, Charlotte. He is co-editor of *Visiones*, a literary anthology for students of Spanish and international business. He is co-author with Germán Torres of *Temas del comercio y la economía en la narrativa hispana* (Yale University Press, 2007). He is co-author with Carmen Carney of *Entre Socios: Español para el mundo profesional* (McGraw Hill, 2010) and author of *Angeles Mastretta y el feminismo en México* (Plaza y Valdés, 2010).

Atsushi Fukada is Associate Professor of Japanese and Linguistics and the Director of the Center for Technology-Enhanced Language Learning (TELL) in the School of Languages and Cultures at Purdue University. Dr. Fukada's areas of interests include Japanese linguistics, pragmatics, computational linguistics, and Computer Assisted Language Learning (CALL).
