## **Style Guide of *CLCWeb: Comparative Literature and Culture***

*CLCWeb: Comparative Literature and Culture* (ISSN 1481-4374) is a peer-reviewed quarterly of scholarship in the humanities and social sciences published online in full text and in open access by ©Purdue University and in hard-copy annuals in the Purdue University Press series of Books in Comparative Cultural Studies <<http://www.thepress.purdue.edu/series/compstudies.asp>>. *CLCWeb* publishes scholarship in the widest definition of the disciplines of comparative literature and cultural studies designated as "comparative cultural studies." The journal encourages scholarship in a global, international, and intercultural context and work with a plurality of methods and approaches. In addition to the publication of articles, *CLCWeb* publishes review articles of scholarly books and publishes research material in its *Library Series* <<http://docs.lib.purdue.edu/clcweb/library.pdf>>. Work published in the journal is indexed in the American Humanities Index, in the Annual Bibliography of English Language and Literature, in the Arts and Humanities Citation Index, and in the International Bibliography of the Modern Language Association of America. *CLCWeb* is mirrored on the website of the British Comparative Literature Association <<http://www.bcla.org/clcweb/>>, it is preserved at research libraries in the Stanford University lockss system <<http://www.lockss.org/lockss/>>, and it is archived in the *Electronic Collection of Library and Archives Canada* <<http://www.collectionscanada.ca/electroniccollection/>>

Work in *CLCWeb* is published following the MLA: Modern Language Association of America parenthetical sources and works cited format. However, in some instances the said MLA style is modified, as follows:

- 1) In the articles, similar-length paragraphs are encouraged;
- 2) In both text and sources commas and full stops are inside the quotation mark;
- 3) Spelling is consistent whether US-American (e.g., "center" or "neighbor") or British, Canadian, Australian, etc. (e.g., "centre" or "neighbour"), possessive is "Jones's book contains..."; lists of items are with commas as in "her letters, articles, and books indicate that....";
- 4) No footnotes or end notes are used in *CLCWeb* articles; however, in exceptional circumstances such as an acknowledgement of the publication of the same paper elsewhere, a one paragraph text is placed after Note at the end of the paper and before the Works Cited;
- 5) Paper titles should be self-explanatory re the contents/topic of the paper, i.e., metaphorical titles and subtitles are discouraged; epigraphs, mottos, or quotations at the beginning of papers are discouraged; section titles are discouraged, italics and bold for emphases are discouraged;
- 6) When non-English texts are quoted, the English translation is first followed by the original language source and both original and translated sources are listed in the Works Cited, languages in non-Roman alphabets are presented in English transcript;
- 7) In the main text of a paper, sources are cited by the surname of author followed by the page number(s) of the quotation or reference; if an author has more than one source cited in the paper: e.g., (Frye, *The Educated Imagination* 53) or (Frye, "The Code" 25);
- 8) Papers are with a list of Works Cited as follows:
  - 8.1 Sources are in alphabetical order by the author's surname, full first name of author, title of publication, title of name of publication, place of publication, name of publisher (if in a book), and year of publication;
  - 8.2 If more than one book or article by the same author, the surname and first name are repeated each time in full;
  - 8.3 Articles in journals include the number of the volume and the number of the issue in Roman and the year in of publication in parentheses followed by the page numbers of the article;
  - 8.4 Page numbers in hundreds are 112-45 (and not 112-145);
  - 8.5 Titles of journals and books are listed with their subtitles;
  - 8.6 University presses are listed as Stanford UP or The U of Michigan P, followed by the year of the publication;
  - 8.7 Edited works are listed as Sollors, Werner, ed. *Multilingual America: Transnationalism, Ethnicity, and the Languages of American Literature*. New York: New York UP, 1998. & Welsch,

Wolfgang. "Transculturality: The Changing Form of Cultures Today." *The Internationality of National Literatures in Either America: Transfer and Transformation Cases and Problems*. Ed. Armin Paul Frank and Helga Essmann. Göttingen: Wallstein, 1999. 287-308.;

8.8 If a source has two or more authors or editors, the order of their names is Bederman, Gail, and Catherine Stimpson. *Manliness and Civilization: A Cultural History of Gender and Race in the United States, 1880-1917*. Chicago: U of Chicago P, 1996.;

8.9 In the data of a translated work the full name of the translator is listed, following Trans.; wherever possible, the original work of the translation is also listed;

8.10 In Works Cited and bibliographies, articles in edited volumes are listed with their full bibliographies;

8.11 Web sources by hyperlink of primary and secondary sources are encouraged: the web source is linked to in the main text, e.g.: (on Bertalanffy, see also *ISSS: International Society for the System Sciences* <<http://www.issss.org/>>) and the same is listed in the Works Cited with its full bibliographical data, e.g., *ISSS: International Society for the System Sciences* (2001):

8.12 The listing of online sources is, wherever possible, with the name of the web page's author or the name of the web page;

8.13 The listing of CDs and DVDs: Holbein, Hans. *The Ambassadors*. Microsoft Art Gallery: The Collection of the National Gallery, London. CD-ROM. Redmond: Microsoft, 1994;

8.14 E-mail communication: "Re: Utopia." E-mail to Constantin Roman <[roman@aol.com](mailto:roman@aol.com)> (20 August 2002).;
